* MANDATE *

The Indian Agricultural Universities Association is a registered Society, established in November 1967 with Nine Agricultural Universities as its members. Now, all the thirty-eight Agricultural Universities in the country, established upto the year 2002 including 4 National Institutes of ICAR viz. IARI, New Delhi, IVRI, Izatnagar, NDRI, Karnal and CIFE, Mumbai, Deemed to be Universities, are its members.

The main objective of the Association is to promote agricultural research, education and extension in Universities and States and thereby, rural development in the country and also to act as a bureau of information to facilitate communication, coordination and mutual consultation amongst agricultural universities.

All Universities and Institutions (Deemed to be Universities) which provide for an integrated programme of teaching, research and extension education in Agricultural Sciences are qualified to become regular Members of Association.

Vice-Chancellors of all the Agricultural Universities constitute its "General Body". The General Body meets once a year for deciding agenda for the next convention and also for approval of its audited accounts, budget estimates for the next financial year and election of office bearers for the following Calendar year. The "Executive Committee" of the Association consists of President, Vice-President, Secretary-Treasurer and 3 members. They meet every quarter.

The office of the Association is manned by the Executive Secretary.

The Association organizes annual Conventions, National Symposiums and Brain Storming Sessions. These are hosted by one of its Member Universities on the theme selected by the General Body.

The Association has been bringing out a journal of the IAUA annually since 1987, to exchange and promote ideas, as a help to improve norms and standards in education, research and extension in Agricultural Universities. The Association has also been bringing out Quarterly News Letters since 2001, by compiling notable News of the member universities for the information of all the Members.

The main sources of Revenue of the Association are through the subscription from Agricultural Universities and grant from ICAR.

* MANAGEMENT *

The policy making body of the Association is 'General Body' which consists of all the Vice-Chancellors of the Member Universities. The day to day management is vested in its 'Executive Committee'.

2.1 General Body Meeting

The annual General Body Meeting of the IAUA for the year 2002 was held on 10 Dec.' 2002 at ANGRAU, Hyderabad, under the Chairmanship of Dr. I. V. Subba Rao, President IAUA and V.C. ANGRAU, Hyderabad. The main Decisions taken at the Meeting are as under:-

- 1. Approval of the Induction of A.A.I. Allahabad, MA&FSU, Nagpur and UBKV, Coochbehar, as Association's three new regular members.
- 2. To reckon the seniority of V.C., in the case of new Member (s), from the date of Induction of the University into IAUA as regular Member.
- 3. Election of the New Executive Committee for the year, 2003.
- 4. Formation of 'Task-force', comprising of V.Cs of SKUAS&T Srinagar, CSAUA&T Kanpur, WBUA&FS Kolkata, and MPKV Rahuri, to apprise different State Governments for the funding support to SAUs.
- Formation of 'Mountain Forum', Comprising of V.Cs of SKUAS&T Srinagar, GBPUA&T – Pantnagar, CSKKV – Plampur, UBKV – Coochbehar, UAS – Banglore, DBSKKV – Dapoli, IGKV – Raipur and CAU – Imphal, for making in depth analysis of mountain agriculture.
- 6. To hold '28th Annual Convention', at MPKV, Rahuri.
- 7. Approval of Budget Estimate for IAUA Secretarial activities for the year 2003-04.

- 10. "W.T.O and its impact on Indian Agricultural Education Research and Extension" to be the main theme of 27th IAUA annual Convention to be held at ANGRAU, Hyderabad.
- 11. "Sustainability of Agril. production and value addition in Context of W.T.O" to be the topic of IAUA National Symposium 2002-03, approved to be held at SKUAS&T, Jammu.
- 12. To explore the possibilities of advertisements in IAUA year book and Quarterly News Letters, by firms dealing in agriculture, and allied disciplines to raise additional funds for IAUA.

* EVENTS *

3.1 Annual Convention

27th Annual Convention of IAUA on "Agricultural Education, Research and Extension in the Context of WTO" was held at Acharya N.G. Ranga Agricultural University, Hyderabad, on 9-11 December, 2002. The Convention was inaugurated by Sri Nara Chandra Babu Naidu, Hon'ble Chief Minister, Andhra Pradesh. The main Recommendations that emerged in the Convention are:-

- 1. There should be inter-institutional collaboration between all stake-holders.
- 2. The Research organizations in Government as well as private sector should collaborate and share resources to effectively utilize the benefit of advances in gene revolution.
- 3. There is a need to reorient our agricultural education, research, extension and development activities to face National and International changing needs and emerging challenges.
- 4. For rainfed areas, research is needed on watershed development and alternate farming systems.
- 5. Quality infrastructure has to be developed for value addition to utilize surplus or perishable farm produce, more particularly for vegetables, floriculture and Horticulture Sectors.
- 6. Potential of IT and distance education should be fully tapped by the ICAR in collaboration with SAUs.
- 7. The Government policies should be directed to encourage financial institutions towards infrastructure upgradation, market development and export incentives.
- 8. The share of R&D in the total GDP should be raised to at least 1% (2% of agricultural GDP).
- The SAUs should have IPR cells for providing technical support and guidance to farmers regarding Plant Variety Protection and their legal rights.
- 10. Our standards for benchmarking quality must match the international standards to compete in global market.

3.2 National Symposium

National Symposium' 2002-03, on 'Sustainability of Agriculture Production and Value Addition in the Context of WTO', was held on March 20-21, 2003 at Sher-e-Kashmir University of Agricultural Sciences and Technology, Jammu (J&K). The Symposium was inaugurated by Sh. Muffi Mohammod Sayeed, Hon'ble Chief Minister, Jammu and Kashmir. Its main Recommendations are:-

- 1. Reduction in production costs, improvement in quality of agricultural produce and processing and storage facilities with infrastructure need priority attention.
- 2. Specific land use systems of Western Himalayas must take into account quality and size of land holding, degrading soil fertility, low soil temperature, high rainfall and soil erosion.
- Rain-fed areas not suited for crop production, should be developed as pasture and grazing lands for live stock production. This will certainly help in raising the economic status of the farmers.
- 4. Farm machinery like seed-cum-fertilizer drill, which help in timely sowing and fertilizer placement, need to be popularized.
- 5. The contingent plans for aberrant weather conditions need to be developed well in advance and also some policy issues like improvement in credit availability, extension of crop insurance schemes to rain-fed areas etc. need to be taken.
- Benefits should be derived from the advancements in transgenic for insect/pests resistance, reduction in post-harvest losses and development of value-added food products with special reference to improving quantity and quality of oils, proteins and vitamins.
- Since the research in the field of genetic engineering and bio-technology is a costly affair, a joint approach for development of transgenic amongst agricultural and traditional universities should be followed.
- 8. The research and development should give emphasis on pre-harvest management, primary processing, diversified use of products/bio-products and creation of new markets.
- To meet WTO obligations in the years to come, the politicians, bureaucrats and technocrats need to join hands for reduction in cost of production, sustainable production and value addition, so as to cater to the needs of domestic and international market.
- Towards resource conservation technology in agriculture, the participatory approach of farmers or warabandi system of irrigation need to be adopted with the help of line departments.

The Association widened its linkages by approaching various Agricultural Scientific Government and Non-Government organizations like DBT, DST, BARC, NABARD, APEDA, BARC etc. requesting them to circulate their Fund aided Schemes/Projects through our Quarterly News-Letters for the information of Universities.

* MISCELLANEOUS *

9.1 The Committee of the Vice-Chancellors Constituted by ICAR, under the chairmanship of Dr. I. V. Subba Rao, V.C, ANGRAU, Hyderabad, to suggest measures for efficient University governance in the Context of global changes, submitted its report to ICAR in December' 2002. The main recommendations are:-

- The ICAR Model Act, 1994 be amended, specify policy on the establishment of new SAUs and the Search Committee for appointment of V.C may include Nominee of the State Government instead of Chairman UGC.
- 2. Every University teacher should be a Researcher and an Extension specialist.
- 3. SAUs need to be suitably strengthened in terms of infrastructure and human resources development, for effective exploitation of frontier sciences.
- 4. Government should bring out suitable amendments to existing patent laws in the changed scenario of W.T.O.
- 5. R&D efforts should focus on remunerative agri-based farming systems.
- 6. Fund allocation to SAUs need to be stepped up to a level of 2% of GDP from agriculture.
- Decentralization of powers may be examined to reduce the burden and Centralization of powers with V.Cs.
- 8. The Universities should have financial, functional and academic autonomy.
- Modern management system may be introduced to prevent agitation and strikes and appointment of teaching and non-teaching staff may be on contractual basis.
- 10. A separate body like UGC for agriculture with professional approach, financial adequacy and statutory authority on land grant pattern, may be formed.
- 9.2 The Executive Committee of IAUA met the Deputy Chairman, Planning Commission, GOI New Delhi on June 8, 2003 for additional funding support to SAUs. The Planning Commission suggested that SAUs may submit clear-cut proposals for additional fund requirement indicating the areas of research and new management efforts which will result in higher employment, for Consideration by the 'Commission'.

9.3 Shifting of IAUA Secretariat

The IAUA Secretariat has been shifted to new premises at NASC Complex, located at south-west corner of CGIAR block. Apart from having sitting chambers for President and Executive Secretary, it has cubicle for executive staff, a Committee room, a Computer room and space for reprographic facilities. Arrangements have been made to provide working desks for the present and past Vice-Chancellors while on tour to Delhi.

Eight rooms in the International Guest-house at NASC Complex are being placed at the disposal of IAUA exclusively for the member Vice-Chancellors. Members will be intimated the operationalization of this facility, once the physical possession is handed over to the IAUA by ICAR

- 3. General Body Meeting in the month of Oct./Nov.' 2003 at MPKV, Rahuri simultaneously with 28th annual convention.
- To organize 'Brain Storming Session' on "Women empowerment in farm families" at Maharashtra Agricultural and Fishery Sciences University, Nagpur in February' 2004.
- 5. Follow-up appointment with Dy. Chairman, Planning Commission, GOI for stressing additional funding support to Universities.
- 6. Inter-Collaboration with CGIAR National and Inter-national centers / Societies.
- 7. Publication of IAUA year-book.
- 8. To raise Annual membership Subscription from Rs. 20,000/- at present to Rs. 30,000/- from the year 2004-05 with the approval of G.B.
- 9. Convincing ICAR for raising their annual block grant from Rs. 3.00 lakhs to Rs. 10.00 lakhs due to cost escalation and also for taking up some additional activities.

* FINANCE, BUDGET AND AUDIT *

The main source of Revenue of the Association is through the subscription from Member Universities. In addition to it, ICAR also provides a grant of Rs. 3.00 lakhs for National level events like Annual Conventions, National Symposium, Brain Storming Sessions etc. There is also a proposal of raising annual Membership subscription from existing Rs. 20,000/- per University to Rs. 30,000/- per University w.e.f next financial year of 2004-05, if G.B. approves it. ICAR is also being approached to raise their Annual assistance grant from Rs. 3.00 lakhs to Rs. 10.00 lakhs, so that the Association's activities may be expanded.

The Audited Statements of Accounts for the year 2002-03 are given in Annexure – I. From the Accounts it would be seen that total expenditure of the Association during the year is Rs. 12,09,063/- and closing cash balance, Rs. 3,44,203/-. The Association also has a Fixed Deposit of Rs. 54.00 lakhs at the close of the year.
