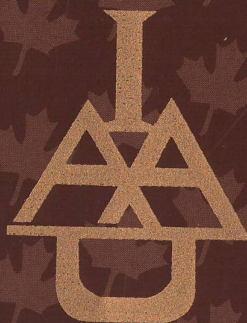

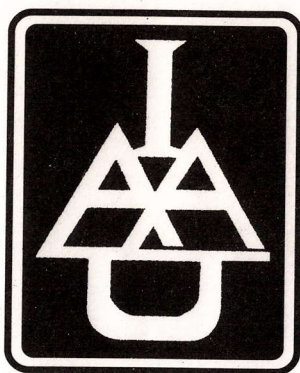

❖ MANDATE ❖

The Indian Agricultural Universities Association is a Registered Society, established in November 1967 with nine agricultural universities as its members. Now out of 40 agricultural universities in the country as on 31 March 2004, 34 state agricultural universities, 4 deemed-to-be universities (IARI, IVRI, NDRI and CIFE) and 1 central agricultural university, are the members of the Association.

The main objective of the Association is to promote agricultural research, education and extension in the universities and states and thereby rural development in the country, and also to act as a bureau of information to facilitate communication, co-ordination and mutual consultation amongst agricultural universities.

All the universities and institutions (deemed to be universities), which provide for an integrated programme of teaching, research and extension education in agricultural sciences, are qualified to become regular Member of the Association.

Vice-Chancellors of member universities or institutions constitute its General Body. The General Body meets once a year for deciding agenda for the next convention and also for approval of its audited accounts, budget estimates for the next financial year and election of office-bearers for the following calendar year. The Executive Committee of the Association consists of President, Vice-President, Secretary-Treasurer and 3 members. They meet every quarter.

The office of the Association is manned by the Executive Secretary, who carries out the decisions of the General Body and the Executive Committee on behalf of Secretary, IAUA.

The Association organizes annual conventions, national symposia and brain-storming sessions, in which subjects of topical interest are discussed. These are hosted by one of the member universities on the theme selected by the General Body.

The Association has been bringing out a journal of the IAUA annually since 1987, to exchange and promote ideas to help improve the norms and standards in education, research and extension in the member universities. It has also been bringing out quarterly newsletter since 2001, by compiling notable news of the member universities for the information of all the members.

The main sources of revenue of the Association are through the subscription from members and grant from ICAR.

❖ MANAGEMENT ❖

The policy-making body of the Association is General Body, which consists of all the Vice-Chancellors of the member universities. The day-to-day management is vested with its Executive Committee.



General Body Meeting

The General Body meeting was held on 20 February 2004 in ICAR Symposium Hall, NASC Complex, New Delhi. The important decisions taken at the Meeting, are given below.

1. The venue of 28th Convention earlier scheduled at MPKV, Rahuri was shifted to SKUAST (K), Srinagar.
2. The following new Executive Committee was elected for the year 2004:

3. The General Body decided to increase the annual membership subscription from Rs 20,000 to Rs 30,000 from the financial year 2004-05 onward.
4. MPKV, Rahuri was approved as the venue for holding the 29th Annual Convention.
5. Financial accounts of the Association for the year 2003-04 audited by the chartered accountant of the Association were adopted.
6. The Association's budget of Rs 12,14,100 for the year 2004-05 was approved.
7. The case of enhancing the retirement age of Vice-Chancellors from the present 65 years to 67 years was decided to be taken up with the concerned authorities.
8. The induction of SVBPUAT, Meerut as the 39th member of the Association was approved.

Four meetings of Executive Committee were held during 2003-2004, viz. on 25 April 2003 at IAUA Secretariat, 23 June 2003 at IAUA Secretariat, 13 November 2003 at MPUAT, Udaipur and 18 February 2004 at IAUA Secretariat. The following important decisions were taken in these meetings:

1. Another meeting with the Planning Commission for early allocation of Rs 500 crores earmarked for SAUs as additional financial support was decided to be arranged.
2. National Symposium on "University autonomy and quality improvement of higher education" was decided to be held at MPUAT, Udaipur.
3. "Women empowerment in farm families" was approved as the topic/ theme for the next Brain-Storming Session.
4. The induction of SVBPUAT, Meerut as the 39th Member of the Association was cleared subject to approval by General Body.
5. "Orient agricultural Education towards future needs and opportunities" was decided to be the topic for 28th Annual Convention of the Association.
6. It was decided to form a Committee to finalize a document on the projects received from various universities for submission to Planning Commission, in pursuance of the meeting held with Deputy Chairman, Planning Commission on 8 January 2003.
7. As a step towards development of linkages and cooperation with CGIAR institutions, it was decided to invite and involve the Centre Heads of these Societies to IAUA national events such as conventions, national symposia etc.

❖ **EVENTS** ❖

National Symposium

A National Symposium on "University autonomy and quality improvement of higher education" was organized during 13-14 November 2003 at Maharana Pratap University of Agriculture and Technology, Udaipur. The main recommendations of the symposium are given below.

1. The concept of autonomy should be crystallized and its implications should be specified with respect to academic, financial, administrative and legal perspectives.



2. There is a great need for complete autonomy at all levels, including the freedom to start new courses, create new posts and re-deploy the staff.
3. The revenue generated by the university should be kept apart for the development of the university and should not be deducted from the annual grants-in-aid.
4. The Model Act of the ICAR must be reviewed, and after necessary amendments it must be implemented in letter and spirit by all the agricultural universities in the country.
5. The intake for higher education must be restricted strictly on the basis of merit and the remaining substandard outturned students should be diverted or encouraged to undertake vocational education or training.
6. Job-oriented certificate and diploma programmes, in addition to the regular degree programmes, for upgrading skills and developing confidence among agricultural graduates should be launched to overcome the problem of their increasing unemployment.
7. The 4 year B.Sc. (Agric.) degree programme needs to be reoriented with 2 years study of basic courses and 1 year professional learning. In the IV year the first semester should be devoted for Rural Awareness Work Experience (RAWE) and the second semester for interactive sessions.
8. The degree programmes should include super-specialization in some of the emerging areas such as Natural Resource Management, Hi-Tech Horticulture, Precision Farming, Crop Production and Crop Diversification, Fashion Designing and Rural Home Management. Such super-specializations should be identified in each faculty or discipline.
9. It is necessary to introduce need-based courses and their regular revision is consonance with the changes in socio-economic condition of stake-holders and policies on macro-development strategies at government level.
10. The Master's degree in Agriculture Engineering should be awarded with specialization in major areas of Irrigation Water Management, Renewable Energy Technology, and Post-Harvest Technology and Engineering.
11. A meeting of Deans of all Home Science Colleges and Senior Home Scientists of SAUs and traditional universities should be convened to discuss various issues related to higher education in Home Science in SAUs and to make the programme viable, besides professional and career oriented.

❖ LINKAGES ❖

Linkages with CGIAR institutions and other international associations like AAACU, Phillippines, serving the cause of agriculture in their own way, had been attempted by inviting their Delhi-based representatives to IAUA national events like annual conventions, national symposium etc. These IAUA events are so programmed that at least half a day is devoted to interaction with their local representatives.

❖ MISCELLANEOUS ❖

Mountain Universities Forum

The first meeting of Mountain Universities Forum was organized on 30 July 2003 at IAUA Secretariat. The points that emerged are as follows:

1. Infrastructure of the mountain universities should be strengthened.
2. Budget allocation to the mountain universities should be scaled up.
3. Due to remoteness and security risk, the staff of these universities is compelled to travel by air; hence TA provision must be increased by 100% and additional financial benefits may be considered to attract or retain a competent faculty.
4. IAUA should also be a member of Global Mountain Forum.
5. Additional weightage should be given to the ward of rural families for admission to the SAUs and CAU located in these areas.

❖ FUTURE PROGRAMME FOR 2004-05 ❖

1. To hold the 28th annual convention at SKUAST, Srinagar on the theme "Orient agricultural education towards future needs and opportunities".
2. To hold the 29th annual convention at MPKV, Rahuri.
3. To hold Brain-storming Session or National Symposium on "Women empowerment in farm families" or "Reorganization of SAUs in the light of GDP contribution to the nation".

❖ FINANCE, BUDGET AND AUDIT ❖

The main source of revenue of the Association is through the subscription from Member Universities. In addition, ICAR also provides grant of Rs 3 lakhs for organizing national-level events like Annual Convention, National Symposium, Brain-storming Sessions etc. the annual Membership subscription has been raised from the existing Rs 20,000 to Rs 30,000 w.e.f. next financial year 2004-05. The ICAR is also being approached to raise its annual assistance grant from Rs 3 lakhs to Rs 10 lakhs, to enable the Association expand activities.

The Audited Statement of Accounts for the year 2003-04 is given in Annexure I. It shows that total expenditure of the Association during the year is Rs 8,99,565 and closing cash and bank balance Rs 4,60,925. The Association also has a Fixed Deposit of Rs 50 lakhs at the close of the financial year 2003-04.
