MANDATE

The Indian Agricultural Universities Association is a Registered Society under Registration no. 3498 of 10 November, 1967. It was established in November 1967 with nine agricultural universities as its founder members, viz. PAU, Chandigarh (now Ludhiana); APAU (now ANGRAU), Hyderabad; JNKVV, Jabalpur; UPAU (now GBPUAT) Pantnagar; UAS, Banglore; KU, Kalyani (now BCKV, Mohanpur); OAUT Bhubaneshwar; UU (now MPUAT, Udaipur) and IARI, New Delhi.

During this long span there has been phenomenal increase in the number of member universities, especially during the late 90s and onwards. At present the strength of association membership is 44 agricultural universities, i.e. 38 state agricultural universities, 5 deemed-tobe universities (AAI, IARI, CIFE, IVRI and NDRI) and 1 central agricultural university. All these are regular members of the Association.

The main objective of the Association is to promote agricultural research, education and extension in the universities and states, and thereby rural development in the country. It also acts as a bureau of information to facilitate communication, co-ordination and mutual consultation among agricultural universities. The Association also acts as a liaison between member universities and government departments to facilitate communication and expedite the needed action in matters of importance.

All the universities and institutions (deemed-to-be universities) in India, which provide an integrated programme of teaching, research and extension education in agricultural sciences, are qualified to become regular members of the Association.

Vice-Chancellors of member universities or institutions constitute the Association's General Body. The General Body meets once a year to decide the agenda for the next convention as also for approval of its audited accounts and budget estimates for the next financial year, besides the election of the office- bearers for the following calendar year. The Executive Committee of the Association consists of President, Vice-President, Secretary-Treasurer and three members. The Executive Committee meets quarterly.

The office of the Association is manned by Executive Secretary, who implements the decisions of General Body and Executive Committee on behalf of the Association. A quarterly newsletter is also being published by the Association since 2000, giving important news, events and actions by member universities for the information of all the members.

The main source of revenue of the Association is the annual subscription from member universities. The ICAR also gives a nominal grant annually

EVENTS

Round-table Conference of Vcs & Directors of Agricultural and Technical universities

For the first time an event was jointly organized by the IAUA and AIU under the ICAR sponsorship on 19-20 July 2005 at IAUA, New Delhi, especially during the centenary celebrations of the IARI. In this conference, agricultural and technical universities participated. The meet was presided over by Prof. Vachaspati Upadhyaya, President, AIU. The Union Minister for Agriculture, Shri. Sharad Pawar, was the Chief Guest on this occasion.

All the participants expressed their views and were unanimous that synergy and compliment it through collaboration will lead



to quality assurance in education and faster development of technologies. To begin with, enabling environment need to be created by free flow of short visits of scientists/faculty to understand the strength among institutions.


A Research coordination committee was formed, consisting of Chairman (President, AIU), Co-Chairman (President, IAUA), 2 VCs from SAUs, 2 Directors (1 each from IIT and 1 from NIIT), 1 VC from State technical university, 2 VCs from general universities, 1 VC from deemed technical university, 1 VC from deemed agricultural university, 1 member each from the ICAR, 1 UGC, and AICTE, and the Convenor Secretary-General, AIU.



Brainstorming session

A Brainstorming session was held at IVRI, Banglore Campus on 17-18 August 2005 on "Distance education in agriculture". The main recommendations are as under: -

- 1. There is general consensus that SAUs, DUs and CAU should not award formal degrees through ODEL in agriculture and allied disciplines at present and instead focus on catering to societal needs on demand driven vocational, entrepreneurial education and continued educational programmes for farmers, extension workers, rural youth and capacity building of agricultural graduates and faculty using ODEL.
- As a first step, in capacity building on ODEL activities and programmes at SAUs, each university may identify a Nodal Officer to eventually establish a Co-ordinating Cell on Distance Education. ICAR should be approached for funding under National Agricultural Innovation Project (NAIP) for establishment of Distance Education Cell at all SAUs and CAU.
- 3. Considering the paucity of specialised cadre of Animal Husbandry and Veterinary extension workers to promote livestock health and production based extension services in the State line departments, there is an urgent need to provide qualified veterinary extension specialists or alternatively give intensive training and exposure on Animal Husbandry and Veterinary extension programmes to the existing agriculture extension workers.
- 4. ICAR should take the responsibility of training the faculty in SAUs and DUs on distance education and learning techniques and developing the course content with the involvement of agencies like IGNOU, ICRISAT, NAARM, Dept. of Information Technology etc.
- A provision may be made for engaging experts for awareness creation and training of the faculty in SAUs, DUs, CAU in distance education activities from the ICAR Education Development Grant under the Head HRD.



Regional Meeting

The Regional Meeting was held at Sher-e-Kashmir University of Agricultural Sciences & Technology of Kashmir, Srinagar (J&K) on 9-10th September 2005 on "Policy paper on Control of admission, improvement in examination/ evaluation system and invigilation of examinations, course curricula and mechanism for affiliation of private colleges with SAUs". The major recommended Policy Guidelines on Private Agricultural Education are as under: -

- The management of the private college/ institution should be transparent and the affiliation of such private college, imparting UG/PG teaching in agriculture and allied sciences, need to be invariably under the regulatory control of SAUs alone.
- Element of affiliation should be incorporated in the Model Act.
- 3. Affiliation should be temporary, for a period of 10 years, subsequently renewable by adopting norms relevant at that time.
- Affiliation procedure should be well laid out in consonance with the university academic processes and mandate.
- 5. There is need for establishing accreditation norms for affiliated private colleges.
- 6. Costs involved in accreditation should be borne by the institution seeking affiliation.

- 7. Accredited private colleges should be eligible for financial assistance from ICAR.
- 8. The admission procedure and courses of both constituent as well as affiliated private colleges need to be in accordance with the practice in vogue in the SAUs to which the college is affiliated.
- 9. Affiliated college should recruit/employ qualified competent teachers for which the pay structure shall be similar as prevalent in SAU.
- 10. The college management committee should include Dean and concerned Director Resident Instruction or nominee of the Vice-Chancellor as members.
- 11. Resident Instruction Rules and procedures/Academic regulations of the SAU concerned be followed.
- 12. Course curriculum and academic regulations at affiliated colleges should be same as followed by the SAUs for their constituent colleges.
- 13. Examination, invigilation, evaluation and award of the transcript and degree/certificate etc. should rest entirely with SAU.
- 14. Failure to comply provision of MoU/directives of the University within the stipulated time, the Vice-Chancellor may withdraw the affiliation.

National Symposium

A National Symposium was held at Indira Gandhi Agricultural University, Raipur on 10-11 November 2005 on "Agricultural technological backstopping through education and training for Self-employment". The major recommendations are: -

- 1. The HRD programmes should be liberal and timely implemented.
- 2. One percent of Agricultural GDP should be allocated to NARS with rational distribution to education, research and extension education.
- 3. There is need to examine the existent course which have many good aspects and change the curricula if needed.
- 4. It is necessary to strengthen the areas like taxonomy, disaster management, IPR etc.
- 5. There is a great need to revamp the Home Science course curricula.
- 6. The SAUs have a great strength to internationalize higher education and for this necessary specialization, infrastructure etc. need to be developed.
- 7. The SAUs may identify the niche areas and develop the needed course curricula in the niche areas across the disciplines for attracting international students.
- 8. The ICAR may provide proper guidelines for the course equivalence of graduate students from foreign countries.
- 9. It is necessary to develop course curricula and necessary infrastructure for offering vocational courses in Agriculture, Veterinary sciences, Animal husbandry, Dairy Sciences and Fisheries.
- 10. Trained technicians are needed and vocational courses in dairy sector are to be developed and popularized among the youth, especially rural youth.
- 11. Some scope may be given for consideration of need based courses also in addition to the common one taught to ensure uniformity.
- 12. Uniform admission procedure should be adopted in all SAUs.
- 13. There may be specialization in agricultural engineering extension in SAUs.
- 14. Close collaboration with industrial extension centers and R&D institutes is desirable.
- 15. The ratio of extension workers a farmers is very wide. There is a need to reduce the gap to make the extension effective. Agri-clinics and Agrio-business centers can fill the gap and support the extension services.
- 16. Confidence building among the students is the need of the hour. There must be some curricula to built up confidence among the students to develop self-employment. For such activities, the support of infrastructural development funds should come from ICAR.
- 17. Privatization of extension services is inevitable in the present context of agriculture. Even other countries in the world are doing privatization. It is necessary to have public-private



sector linkage and co-ordination for agricultural extension.

- 18. E-extension has a great potential in India. Development of rural infrastructure is necessary for utilization of the e-extension potential in India.
- 19. Contract farming can, in one way, help the small and medium farmers to get assured technological support for crop production as well as assured marketing of their products. However, proper legislative protecting measures are needed to avoid exploitation of the farmers.
- 20. In rainfed areas, blending of traditional and modern technologies is very much needed for better adoption of technology.

30th Annual Convention

The 30th Convention was held at Sardarkrushinagar Dantiwada Agricultural University, Sardarkrushinagar on 27-28 December 2005 on **"Effective management of agriculture waste".** The Major recommendations are: -

- 1. Treatment of city waste-water should be made mandatory for using it in agriculture and there should be segregated industrial wastewater and domestic sewage water.
- 2. Treatment methods and the minimum standards of the use of sewage water need to be standardized as per soil, crop and weather condition.
- The house was of the opinion that a task force should be constituted to compile information already available on various aspects in the use of sewage water in agriculture. The task force should be asked to identify critical gap and researchable areas.



- 4. The convention also laid emphasis on very effective and selective use of biomass for energy generation. The exploitation of *ratanjyot* (Jatropha) for energy generation should be done with care by growing it only on the degraded or marginal lands.
- 5. Further, the convention felt that about 50 million tones of fruits and vegetable waste that is currently available should be efficiently utilized for various value added products and the areas of management of fruits and vegetable waste should be identified and prioritized.
- It was suggested to establish referral laboratories for monitoring and guiding the residues in fruits and vegetables to overcome the rejection of export consignment and health hazards and thus to avoid the wastage.

Special Meeting

A Special Meeting of Animal, Veterinary & Fishery sciences universities or institutes" was held at College of Veterinary and Animal Sciences, Selesih, Aizawl, (Mizoram) on 13 March 2006. The following Recommendations emerged out of the deliberation or discussion at this special meeting: -

- 1. Participation of farmers while planning for developmental programmes.
- 2. Each farmer should be taken up as a unit of farming system practitioner
- 3. Media should be involved to highlight the gains and achievements.
- 4. The ban should be lifted on filling up of the vacancies lying vacant in veterinary, animal husbandry and fisheries universities or colleges.
- 5. Some mechanism is to be developed to have linkages in veterinary universities.
- 6. For fishery universities, separate or special funds should be allocated for the purchase of fishes and seeds.





- For veterinary universities, separate essential funds should be provided for ladies training 7. hostels.
- 8. Suitable internship or scholarship should be paid to the veterinary graduates.
- 9. The veterinary universities should be treated on a par with the new agricultural universities being opened.
- 10. The ICAR should restart the catch up-grant for the repair and maintenance of old buildings.
- 11. The project "Vidya dairy" should be started and funded separately.
- 12. Special projects on meat and fish technology, should be allowed to start on the same grounds as Vidya dairy.

LINKAGES

For the first time a link with AIU, New Delhi was developed and a 2-day Round-table conference of Vcs or Directors of agriculture and technical universities was organized jointly by IAUA and AIU on 19-20 July 2005 at NAAS Auditorium, NASC Complex, New Delhi.

Possibility of co-operation between Indian Agricultural Universities and Kazakh National Agrarian University, Kazakhstan is also being explored.






It shows that total income of the association from annual membership subscription is Rs 13,20,000 (Thirteen lakhs twenty thousand) and total expenditure as Rs 11,45,042 (Eleven lakh forty five thousand and forty two only). The association also has fixed deposits of Rs 55 lakhs at the close of the financial year 2005-06.
