# MANDATE

The Indian Agricultural Universities Association (IAUA) is a Registered Society under Registration no. 3498 of 10 November, 1967. It was established in November 1967 with nine agricultural universities as its founder members, viz. PAU, Chandigarh (now Ludhiana); APAU (now ANGRAU), Hyderabad; JNKVV, Jabalpur; UPAU (now GBPUAT), Pantnagar; UAS, Bangalore; KU, Kalyani university (now BCKV, Mohanpur); OUAT, Bhubaneshwar; UU (now MPUAT), Udaipur and IARI, New Delhi.

During this long span there has been phenomenal increase in the number of member universities, especially during the late 90s and onwards. At present the strength of the IAUA membership is 56 including i.e. 49 state agricultural universities, 5 deemed-to-be universities (IARI, IVRI, NDRI, CIFE and SHIATS) and 2 central agricultural universities (CAU, Imphal and BHU, Varanasi). All these are regular members of the Association.

The main objective of the Association is to promote agricultural research, education and extension in the universities and the states, and thereby rural development in the country. It also acts as a bureau of information to facilitate communication, co-ordination and mutual consultation among agricultural universities. The Association also acts as a liaison between member universities and government departments to facilitate communication and expedite the needed action in matters of importance.

All the SAUs and institutions (deemed-to-be universities) and (Central Agricultural Universities) in India, which provide an integrated programme of teaching, research and extension education in agricultural sciences, are qualified to become regular members of the Association.

Vice-Chancellors of member universities constitute the Association's General Body. The General Body meets once a year to decide the agenda for the next convention and also for adoption of its audited accounts of the year and approval of budget estimates for the next financial year, besides the election of the office-bearers for the following calendar year. The Executive Committee of the Association consists of President, Vice-President, Secretary-Treasurer and three members. The Executive Committee meets quarterly.

The office of the Association is manned by Executive Secretary, who implements the decisions of General Body and Executive Committee on behalf of the Association. A quarterly newsletter is also being published by the Association since 2000, giving important news, events and achievements by member universities for the information of all the members and other interested. An Annual report is also published documenting all the activities of the year.

The information on events are also included in website (www.iauaindia.org) and published by the host university on the event to be circulated to all the VCs of member universities and other main stake holders.

The main source of revenue of the Association is the annual subscription from member universities. The ICAR also provides a nominal grant annually.

# **EVENTS**

1) "Special General Body Meeting" was held during 27th April 2012, at Sher-E Kashmir University of Agricultural Sciences and Technology, Srinagar.

#### Following observation were:

- The Land Grant pattern of Agriculture University education and research should be revisited and a request for setting up a National Commission on Agriculture Education be sent to ICAR.
- 2. SAUs may be involved in implementing second Green Revolution programs.
- 3. The Government may consider establishing a Central Agriculture University preferably in each state with appropriate synergies with the existing SAUs.
- 4. More academic and financial autonomy may be given to SAUs and central assistance to the Agricultural Universities should be enhanced atleast five time.
- 5. Liberal funding under RKVY, NFSM and ATMA may be given to the Agricultural Universities as per their need and involvement in research and extension.
- 6. A separate budget line should be made in the State plan for agricultural research and eduction.
- 7. VCs should be given autonomy to reallocate some CDA grants as per need of the University.



# 2) Recommendation of 37th Annual Convention of VCs held at Jaipur during 27-28 December, 2012.

#### Theme: "How to make agriculture more remunerative for small farmers"

- Small and marginal farmers all over the country should be encouraged for growing of fruits and vegetables along with livestock and fisheries with the help of incentives form the government in terms of subsidies and/or cluster approach for marketing and strengthening of supply chain to ensure maximum price of their produce.
- The small farmers area may be demarcated for specific crops, diversification and they be helped in post harvest technology with processing of crops and animal products with the help of mechanization in farming system where animal component should form an integral part.
- Efforts are also needed from the government involving self help groups or farmers co operatives to create animal hostels by providing infrastructure and financial support for small farmers.
- ICT should be popularized by the governments to reach to the individual small farmers more prominently to the interior areas for technology transfer and trainings at village level.
- 5. There is need to develop various processing and value addition models applicable to the small farmers where food processing and marketing should be encouraged through small farmers self help group (SHG) and co-operative societies.
- 6. Special live stock and fisheries packages be given to the small farmers in the suicide prone district of Andhra Pradesh, Maharashtra, Karnataka and in general to be popularized all over the country.
- Special weather based crop insurance policy should be developed for small farmers all over the country to protect them in case of any crises and disasters.
- Through the development of SAU's extension centers at tehsil and village level e-Kios may be installed for timely and speedy dissemination of knowledge.
- Refinement and upscaling of technologies particularly for efficient irrigation system and green house cultivation be encouraged to mitigate the effect of climate change in vulnerable areas of the country.
- 10. For every agricultural and livestock products value addition at farmers level and bottom up marketing is the need of the hour for enhancing profitability of the small farmers required to be vigorously promoted.
- 11. The issue of private agriculture colleges including veterinary may be resolved by ICAR through the IAUA initiatives and intervensions.
- 12. Specific efforts should be made for conservation of traditional breeds in animal and crop varieties through the support of the government.
- 13. A network supported by government of India, ICAR and NABARD etc, may be developed for small farmers in agricultural education system with a dedicated curriculum specifically addressed to small farmers productivity, problems and viability issues. One SAU concept may be developed through networking. It should prove the milestone in agriculture for the benefit of small farmers in the country.


#### Dr T.A.More was made Hon. Colonel of NCC

# FINANCE, BUDGET AND AUDIT REPORT

The main source of revenue of the Association is the subscription from member universities. In addition, the ICAR also provides a good assistance of Rs 20 lakhs annually for organizing national - level events like Annual Conventions, National Symposia and Brainstorming sessions etc.

The audited Statement of Accounts for the Year 2012-13 is given in **Annexure 1.** It shows that total income of the Association is **Rs. 39,96,819/-** (Rupees Thirty Nine Lakhs Ninety Six Thousand Eight Hundred Sixteen only) (i.e., i) Rs.27,50,000/- as membership subscription, ii) Rs.466984/- as interest from bank) (Rs. 20,00,000/- as grant from ICAR received during April, 2012, hence not included in the receipt) and total expenditure **Rs.25,86,786/-**(Rupees Twenty Five Lakhs Eighty Six Thousand Seven Hundred Eighty Six Only). At the close of the financial year 2012-13, the Association has fixed deposits of **Rs.86,66,428/-**(Rupees Eighty Six Lakhs Sixty Six Thousand only), which will be Rs. **1,11,53,854/-** as on 28th January 2014.


